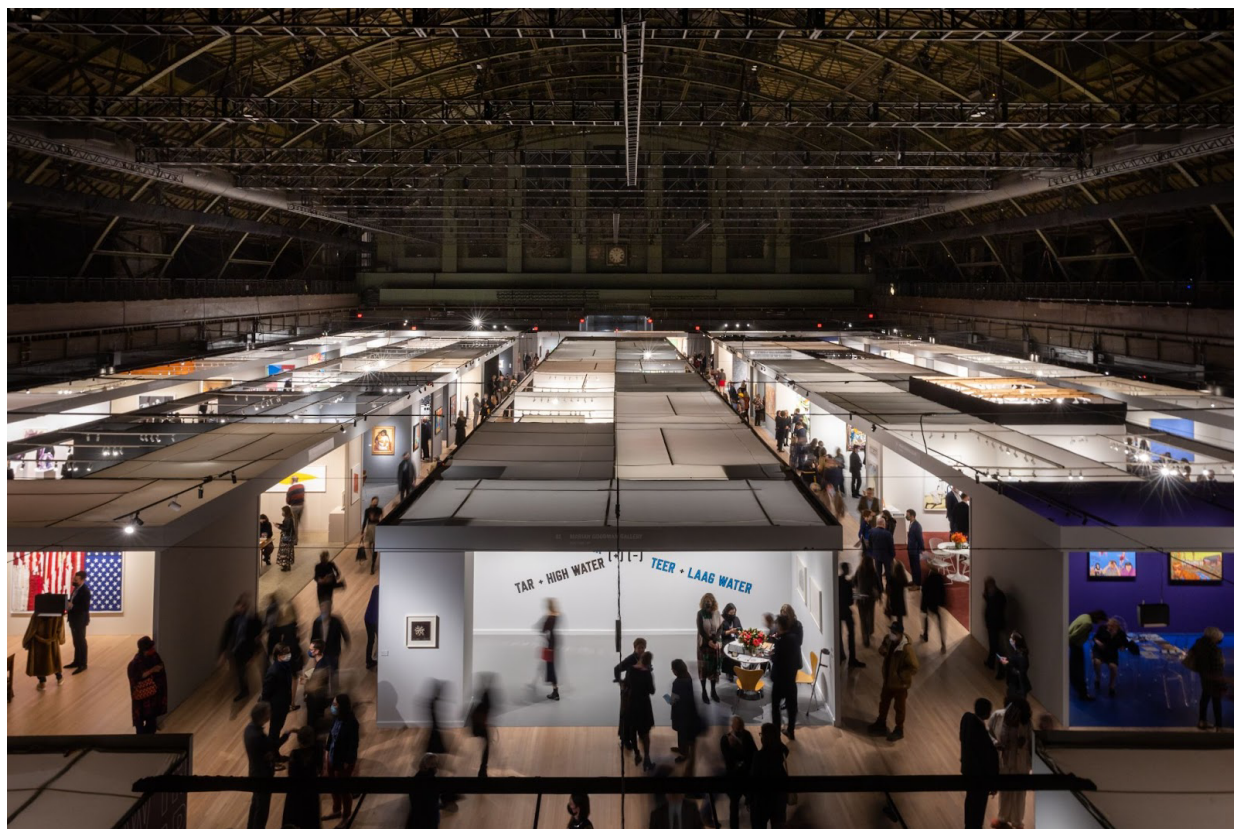


## Art Dealers Association of America announces exhibitors for milestone 35th edition of The Art Show

Coinciding with the 130th anniversary of Henry Street Settlement, the 2023 edition continues The Art Show's philanthropic mission to support one of the nation's oldest social services organizations

**(June 22, 2023—New York City)** The Art Dealers Association of America (ADAA) is pleased to announce the milestone 35th annual edition of [The Art Show](#), one of the longest-running art fairs in the country. Founded as a means to bring ADAA members together while benefiting **Henry Street Settlement**, the fair will continue to donate all admissions proceeds to the social services organization, which also celebrates its 130th anniversary this year. The 2023 edition takes place in the historic Park Avenue Armory, with the annual Benefit Preview on **Wednesday, November 1**, and is open to the public from **November 2-5**. For the 12th consecutive year in 15 years of partnership, **AXA XL**, a division of AXA, returns as the Lead Insurance Partner of The Art Show, providing specialist fine art and collectibles risk-management solutions.

This year, The Art Show will feature booths from **78 ADAA member galleries**. Of these, an impressive 56 booths will feature solo exhibitions—including standout presentations by **Tavares Strachan** with Marian Goodman Gallery (New York), **Joel Mesler** with Cheim & Read (New York), **Sheila Hicks** with Sikkema Jenkins & Co. (New York), **Roy Lichtenstein** with Castelli Gallery (New York), **Tom Wesselmann** with Almine Rech (New York), and **Kiki Smith** with Pace Gallery (New York & Los Angeles).

This year, the fair is pleased to include presentations by several new ADAA members, including: **Nicelle Beauchene Gallery** (New York), **Catharine Clark Gallery** (San Francisco), **Anat Ebgi Gallery** (Los Angeles), **Eric Firestone Gallery** (New York & East Hampton), **Gitterman Gallery** (New York), **Ortuzar Projects** (New York), **Perrotin** (New York), and **SKOTO GALLERY** (New York). ADAA stalwarts like **Kasmin** (New York), **Sperone Westwater** (New York), and **Sean Kelly** (New York & Los Angeles) also return this year as time-honored presenters alongside participants from the first-ever fair in 1989, such as **Berggruen Gallery** (San Francisco), **Hirschl & Adler** (New York), **Mary-Anne Martin | Fine Art** (New York), **Barbara Mathes Gallery** (New York), and **Schoelkopf Gallery** (New York).

The Art Show was jointly conceived in 1989 by the ADAA and Henry Street Settlement—one of the country's oldest nonprofit organizations, founded in 1893 under the name Nurses' Settlement. Each year, Henry Street directly supports **50,000 New Yorkers** in need through its education, employment, shelter, health and wellness, and arts programs. The Art Show has raised more than **\$36 million** over the past three decades and continues to be Henry Street's greatest source of unrestricted funding. All admission fees from the run-of-show go to Henry Street, along with the proceeds from the Benefit Preview gala evening, one of New York society's most cherished annual events.

**Maureen Bray, ADAA Executive Director:** "This is a special year for The Art Show as it celebrates two milestone anniversaries—its very own 35-year run and Henry Street Settlement's 130th year of operation—which demonstrates how the generative collaboration between our two organizations has had a tremendous and time-honored impact on the lives and well-being of our communities."

For more than 60 years, the ADAA has supported the nation's leading fine art galleries, allowing them to focus on the economic and cultural contributions they offer their local communities and the world at large. Today, the organization includes over 200 diverse members from nearly 40 U.S. cities, with these galleries representing hundreds of established and emerging artists internationally. As the only fair with a rigorous peer review process in which all booth proposals are vetted by the ADAA member galleries that have applied, the resulting standard of connoisseurship has become synonymous with The Art Show.

This year's 56 booths offering solo presentations promote focused critical attention on a wide range of artists, from key art historical figures to intergenerational voices in contemporary art. They include:

- **Richard Mayhew: *Mindscapes***, a presentation of paintings and watercolors that celebrates the artist's iconic landscape paintings by **ACA Galleries**.
- **Peter Blum Gallery's** survey of work by the late artist **Sonja Sekula** (1918–1963), whose practice oscillated between Surrealism and the newly emerging tendencies of Abstract Expressionism.
- Works by **Roy Lichtenstein** (1923–1997) including paintings, sculptures, collages, and drawings that analyze the relation between abstraction and figuration, presented by **Castelli Gallery**.
- **Cheim & Read's** presentation of never-before-seen paintings from Joel Mesler's series of rabbinical portraits, titled *The Rabbis*.
- **DC Moore Gallery's** presentation of new works by **Whitfield Lovell**, an artist known for his masterful conté crayon drawings, assemblages, and installations.
- Historic and recent works by ecofeminist **Faith Wilding**, whose work addresses the deterioration of the natural world, spiritual exuberance, and biopolitics, presented by **Anat Ebgi Gallery**.
- A presentation by **Derek Eller Gallery** focused on **Jameson Green's** new narrative-based paintings.
- **James Fuentes's** immersive installation of new large-scale works by **John McAllister**.

- New mixed-media, multilayered paintings, and sculptural works by **Tavares Strachan**, presented by **Marian Goodman Gallery**.
- Works on paper by the late Iranian-American artist of the New York School, **Manoucher Yektai** (1921–2019), presented for the first time ever by **Karma**.
- **Sean Kelly**'s presentation of never-before exhibited photographs by **Alec Soth** on the subject of hypnagogia, the transitional state between wakefulness and sleep.
- Rarely exhibited wall-based works by **Betty Woodman** (1930–2018), presented by **David Kordansky Gallery**
- A suite of new cutouts on specialty papers by **Jasmin Sian**, presented by **Anthony Meier**.
- **moniquemeloche**'s presentation of 84-year-old **Arvie Smith**'s riotous, colorful paintings, which render the embedded truths in American cultural history and his own lived experience as a Black man, while touching heavily on the American experience.
- The U.S. debut of watercolors by the French artist and writer **George Sand** (1804–1876) in **Jill Newhouse Gallery**'s booth.
- **David Nolan Gallery**'s presentation of American artist **Chakaia Booker**, showcasing a decade of her oeuvre and the variety of her media, including rubber tires, bronze, and ceramic sculpture; painting; drawing; and prints.
- Drawings, sculptures, and tapestries by **Kiki Smith** with **Pace Gallery**.
- **Almine Rech**'s presentation of **Tom Wesselmann** (1931–2004), featuring works on paper, canvas, and steel, spanning the artist's decades-long career.
- A selection of collages, paintings and works on paper dating from 1945 to 1969 by **Charmion von Wiegand** (1896–1983), presented by **Michael Rosenfeld Gallery**.
- **Schoelkopf Gallery**'s presentation of large-scale photorealist works by **Richard Estes** highlighting the artist's enduring devotion to capturing the architecture of New York City.
- New works by **Sheila Hicks** in a focused presentation by **Sikkema Jenkins & Co.**
- A new series of paintings by **Shaun Leonardo** depicting the hands of his spiritual teachers, presented by **Cristin Tierney Gallery**.
- **Michael Werner**'s presentation of new paintings by Germany-based, Japanese artist **Maki Na Kamura**.

The two-person and group presentations at The Art Show examine a diverse range of art historical moments and cultural traditions, from Mexican and Latin American modernism to Czech photography of the early to mid-twentieth century to a historic presentation of Asian American artists to a re-examination of historic museum exhibitions of African American art. Highlights from these curatorially rigorous multi-artist booths include:

- *Double Vision: Rethinking Manifest Destiny*, a presentation by **Catharine Clark Gallery** of **Marie Watt** and **Stephanie Syjuco**, draws on frontier histories to imagine narratives that critique American mythologies.
- **Eric Firestone Gallery**'s tribute to historic museum exhibitions of African American art, featuring works by **Ellsworth Ausby** (1942–2011), **Joe Overstreet** (1933–2019), **Anderson Pigatt** (1928–2009), **Thomas Sills** (1914–2000), and **Paul Waters**.
- A presentation by **Debra Force Fine Art** of significant paintings, works on paper, and sculpture exploring the various artistic movements in twentieth-century American Art.
- A booth dedicated to avant-garde Czech photography from the late 1920s to early 1950s, focusing on **František Drtikol** (1883–1961) and including work by **Josef Sudek** (1896–1976), **Jaromír Funke** (1896–1945), **Miroslav Hák** (1911–1978), and **Emila Medková** (1928–1985), presented by **Gitterman Gallery**.

- **Kasmin's** exhibition exploring the use of primordial and biomorphic forms by six artists, from **Lee Krasner's** 1969 *Earth No. 5* to the New York debut of **Bosco Sodi's** gold-glazed spheres.
- A historical presentation by **Tina Kim Gallery** highlighting two seminal Asian and Asian American artists: sculptor **Minoru Niizuma** (1930–1998) and painter **Kim Tschang-Yeul** (1929–2021).
- Masterworks by modern Mexican and Latin American artists working across a variety of artistic styles and movements of the twentieth century, including Mexican Muralism, Surrealism, and Modernism, presented by **Mary-Anne Martin | Fine Art**.
- **Barbara Mathes Gallery's** booth featuring artists such as **Frank Bowling**, **Ed Clark** (1926–2019), **Joseph Cornell** (1903–1972), and **Sam Gilliam** (1933–2022), who rethink the tools of art-making and develop new ways of applying pigment.
- A two-person presentation by **Perrotin** of **Claire Tabouret** and **Nathan Thelen** who will create a series of new sculptures meditating on wood, both as a medium of craftsmanship and a tool of creative expression through fine artworks.
- An examination by **Leon Tovar Gallery** of the new connections and cross-cultural dialogue between the Argentine artists **Martín Blaszkó** (1920–2011) and **Alicia Penalba** (1913–1982).

**Anthony Meier, President of the ADAA:** “With each edition, The Art Show only gets stronger in its selection of exhibitors and the caliber of presentations—and our 35th anniversary makes that especially evident. As the product of a rigorous peer review process, which all ADAA members undergo to be admitted to the organization, the fair itself showcases the best that America’s leading fine art galleries have to offer, and does so with the care and dedication of a close-knit community working towards a shared vision.”
