

## Art Dealers Association of America Establishes New Fall Dates for The Art Show, Annual Fair to Benefit Henry Street Settlement

### 2021 Edition to be Held November 3-7 at Park Avenue Armory in New York

**New York, NY (February 3, 2021)** – The Art Dealers Association of America (ADAA) today announced new fall dates for The Art Show, the leading fine art fair organized by the ADAA to benefit Henry Street Settlement. Held annually at the Park Avenue Armory in New York, The Art Show brings together members of the ADAA, the nonprofit organization of the nation’s leading art dealers, to showcase incisive curated exhibitions of artists from the 19<sup>th</sup> century to today. The fair’s 2021 edition will take place November 3 through 7, kicking off with a benefit preview on Wednesday, November 3.

“The Art Show has always been distinguished by the exceptional visitor experience it provides – comprised of outstanding presentations, an easily navigable scale, and an unhurried environment that encourages meaningful engagement with works of art. Throughout this challenging year for the art world, we have been working closely with our partners of more than three decades, Henry Street Settlement and the Park Avenue Armory, to ensure we could continue to deliver this unparalleled art experience for visitors and our member dealers into 2021 and beyond. With the 2021 edition of the fair, we are excited to establish a new date on the fair calendar and further strengthen the fair’s position as a favorite of collectors and galleries alike,” said Anthony Meier, Vice President of the ADAA and Chair of the ADAA’s Art Show Committee.

All proceeds from admission to The Art Show and the preview benefit Henry Street Settlement, one of New York’s leading social service, arts, and health care organizations. As Henry Street Settlement’s greatest source of unrestricted funding, The Art Show has raised over \$33 million for the nonprofit through more than three decades of partnership between Henry Street Settlement and the ADAA.

“As Henry Street continues to respond to the profound effects on our community of the coronavirus public health and economic crisis, we rely more than ever on the critical and incredibly generous support provided by The Art Show and its patrons, all made possible through our partnership with the Art Dealers Association of America,” said David Garza, President and CEO. “This unrestricted funding is what has enabled Henry Street to pivot literally overnight, providing meals to our shelter residents so they could remain in place; creating three emergency food pantries that are serving thousands of New Yorkers; providing emergency cash assistance, including a fund dedicated to unemployed arts workers; launching a Helpline; and moving multiple programs, including art classes and performances, online.”
